If total payment is not made the day prior to the funeral / memorial ceremony, cremation or transfer out-of-state, the ceremony, interment, entombment, cremation or transfer out-of-state may be postponed.

The purchaser(s) will be responsible for any additional fees incurred due to postponement. Acceptable forms of payment are cash, certified bank check, money order, Mastercard, Visa, Discover and American Express. We will be glad to accept an assignment of insurance proceeds whenever possible. All insurance assignments are subject to a 5% convenience and processing fee per insurance policy. All beneficiaries and death benefit amounts of each insurance policy must be verified prior to the funeral/memorial ceremony or cremation. No life insurance policy will be accepted that has been in effect less than two years or in the contestable period. Annuities and retirement accounts are not acceptable forms of payment. *Cemetery fees are due prior to the interment or entombment and may be required to be paid directly to the cemetery. We do not extend credit or offer payment plans.*
