Basic Services of Funeral Director and Staff \$2,595.00

Our charge for the services of funeral director and staff includes, but is not limited to, staff to respond to initial request for service; arrangement conference with family or responsible party; arrangement of funeral; preparation and filing of necessary authorizations and permits; recording vital statistics; and coordination with those providing other portions of the funeral, e.g. cemetery, crematory and others. Also included in these charges are overhead expenses relative to our facility such as insurance, maintenance, utilities, secretarial and administrative costs, compliance with infectious waste management regulations and employee safety regulations mandated by governmental agencies. This charge for our basic services and overhead will be added to the total cost of any funeral arrangements you select.

Embalming \$895.00

Except in certain special cases, embalming is not required by law. Embalming may be necessary, however, if you select certain funeral arrangements, such as a funeral with viewing. If you do not want embalming, you usually have the right to choose an arrangement that does not require you to pay for it, such as direct cremation or immediate burial.

TERMS/METHODS OF PAYMENT

Total payment is due the day prior to the funeral/memorial ceremony, cremation or transfer out-of-state.

If total payment is not made the day prior to the funeral / memorial ceremony, cremation or transfer out-of-state, the ceremony, interment, entombment, cremation or transfer out-of-state may be postponed.

The purchaser(s) will be responsible for any additional fees incurred due to postponement. Acceptable forms of payment are cash, certified bank check, money order, Mastercard, Visa, Discover and American Express. We will be glad to accept an assignment of insurance proceeds whenever possible. All insurance policy assignments are subject to a 5% insurance policy assignment funding fee. All beneficiaries and death benefit amounts of each insurance policy must be verified prior to the funeral/memorial ceremony or cremation. No life insurance policy will be accepted that has been in effect less than two years or in the contestable period. Annuities and retirement accounts are not acceptable forms of payment. *Cemetery fees are due prior to the interment or entombment and may be required to be paid directly to the cemetery. We do not extend credit or offer payment plans.*
